'Complex or complicated? The COVID-19 vaccine rollout in Australia.'

The difference between complicated and complex policy, and where COVID-19 vaccination rollout sits. Draws on 2009 pandemic influenza vaccination experience, and considers roles of TGA, AHPPC, ATAGI and others in a federal system, and how different vaccine characteristics might impact on decision-making.

'COVID vaccines: how can we combat vaccine hesitancy and achieve high vaccine uptake'

COVID-19 vaccines are being heralded as the solution to control the pandemic & resume our previous way of life. Ensuring public confidence in the COVID-19 vaccines is crucial to facilitate uptake as we can't assume people will accept these vaccines. Low intention to refuse COVID-19 vaccines by adults has been reported in Aust compared to the USA, UK & Europe but we know the population attitudes towards the COVID-19 vaccines will fluctuate with perception of disease severity & vaccine safety & the waves of the pandemic, necessitating regular tracking of vaccine confidence amongst different population groups. Effective risk communication, company engagement with all sectors of the community, especially vulnerable groups, & strong endorsement from government will be crucial to achieve sustained vaccine confidence & uptake. Overcoming vaccine hesitancy & refusal & strategies to achieve high vaccine uptake will be discussed, building on current

She works closely with WHO & Global Vaccine Demand Hub & is part of the Melb Children's Global health Leadership team.
